Let me also request that the application be filled out completely. If it is not, then I will return it to you for completion. Often the applications are given to me with some information missing. The two most common missing components are:

1. Income Tax Return (1040). I want the tax return because I need to have the net income, not gross, which is what your W-2's give me.
2. The amount of scholarship that you are requesting. Comments such as "Whatever you can give me" are not helpful to me at all. Also, please give one amount for the school year. If someone says "X dollars per month", then I do not know if it means for the 12 months of the calendar year, or the 10 months of the academic year, or some other period of time.

As noted above, I am happy to be able to help you send your child/children to St. Paul Catholic School. Please help me by filling out the application completely.
